ORDINANCES

O-5-04 For the purpose of establishing that certain fines shall be set by resolution of the City Council; deleting certain out-dated provisions that apply to fines that are no longer charged; deleting references in the City Code to certain fines that will be included in a fine schedule resolution; establishing certain new fines; providing for the annual adoption of a schedule of fines set by resolution; and all matters relating to said fines.

Alderman Hammond moved to adopt O-5-04 on first reading. Seconded. CARRIED on voice vote.

O-6-04 For the purpose of authorizing the City Council to lease certain municipal property located in the general harbor, Dock Street and Edgewood Road areas to United States Yacht Shows, Inc. and Annapolis Boat Shows, Inc., bodies corporate, for a certain period of time in October 2008, subject to certain terms, provisions and conditions, for the purpose of conducting boat shows; and all matters relating to said lease.
